2. The Supreme Court, the U.S. Court of Appeals for the District of Columbia Circuit, and the U.S. Court of Appeals for the Fourth Circuit have recently issued decisions that may pertain to the issues in this case: (1) *Halbig v. Burwell*, No. 14-5018, 2014 WL 3579745 (D.C. Cir. July 22, 2014); (2) *King v. Burwell*, No. 14-1158, 2014 WL 3582800 (4th Cir. July 22, 2014); (3) *Util. Air Regulatory Group v. EPA*, 134 S. Ct. 2427 (2014); and (4) *Burwell v. Hobby Lobby Stores, Inc.*, Nos. 13-354, 13-356, 2014 WL 2921709 (U.S. June 30, 2014).
3. The parties wish to address these cases and any implications in supplemental briefing.
4. The parties have agreed to the following:
 - a. By August 8, 2014, Plaintiffs will file their supplemental brief. The page limit for this brief should be 15 pages.

- b. By August 22, Defendants will file their response. The page limit for this brief should also be 15 pages.

WHEREFORE, the parties file this Stipulation and request that it be approved, and for all other proper relief.
